A RESOLUTION OF THE SUMMIT COUNTY SERVICE AREA #3 BOARD OF TRUSTEES CERTIFYING THE 2021 GENERAL ELECTION RESULTS

RECITALS

WHEREAS, Summit County Service Area #3 (the “**Service Area**”) is a governmental entity charged with providing water, roads, and trails services to residents of the Service Area; and

WHEREAS, the Service Area’s 2021 general election was held on November 2, 2021; and

WHEREAS, the Service Area’s Board of Trustees (the “**Board**”) serves as the governing body for the Service Area; and

WHEREAS, the Summit County Clerk’s Office received and counted the election returns for the 2021 Municipal Election and has prepared the attached election report; and

WHEREAS, the Board met on November 16, 2021, to canvass the returns of the 2021 Municipal General Election; and

WHEREAS, the Board publicly canvassed the returns and determined from the returns the vote of each candidate.

WHEREAS, the Board desires to certify the 2021 general elections results pursuant to Utah Code Ann. § 20A-4-304.



- d. File a copy of the certified report with the Lieutenant Governor.


