Regulation 2025-05 SECTION 9.0 Transfers of Service. Any property conveyance within the jurisdiction of the Service Area, by sale or lease, requires Service Area authorization to transfer service to the new responsible party. The new responsible party, or "Buyer" as set forth in the Fee Schedule, must complete each of the following to complete a transfer of service:

9.2 Pay all applicable fees in the Fee Schedule and complete a New Account and Welcome to the Service Area Form.
